THE CHALLENGE

Like many companies, Percon Construction's Occupational Health and Safety clerical tasks used to be completed manually by a team that would have much rather spent the excessive administration hours in the field, communicating directly with company personnel.

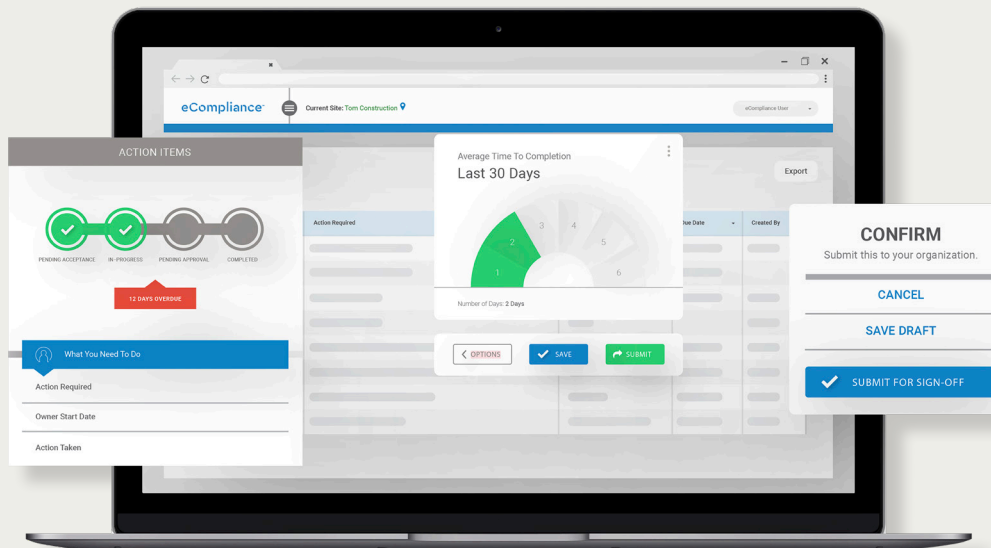
