But after the company kicked off its COR initiative, the health & safety team realized the large volume of paperwork involved would be too complicated to manage and sought out a solution to help them streamline the complex process.

ABOUT THE PARTNERSHIP

Shortly after Zip Signs started working towards COR certification, the EHS team came to the conclusion that relying on their existing paper-driven processes to complete the program was going to be a challenge.
